PRIVACY POLICY

- *What This Policy Covers:*
 - This Privacy Policy covers how The Ticketing Co. (Tixco, LLC) treats personally identifiable information and all other private information collected on the The Ticketing Co. (Tixco, LLC) ticketing and registration system, whether than information is collected via the The Ticketing Co. (Tixco, LLC) website, mobile service, or call center.
 - This Policy does not apply to the practices of event producers, event organizers, and/or third party companies that The Ticketing Co. (Tixco, LLC) does not own or control.
- *Collection and Use of Personal and Financial Information:*
 - The Ticketing Co. (Tixco, LLC) needs certain personal information if you wish to sell tickets for an event, or purchase tickets or register for events through The Ticketing Co. (Tixco, LLC)'s system.
 - This personal information may be used by the other corporate entities owned or managed by the owners or managers of The Ticketing Co. (Tixco, LLC).
 - Where required, this information may include your personal contact information, and possibly credit card information, if applicable. The Ticketing Co. (Tixco, LLC) may use this information to contact you about your event or about tickets you have purchased.
 - The Ticketing Co. (Tixco, LLC) will never sell your information to non-affiliated third parties.
 - By setting up an event or purchasing tickets through The Ticketing Co. (Tixco, LLC), you voluntarily provide The Ticketing Co. (Tixco, LLC) with your personal information and consent to the collection and use of the information in accordance with this Policy.
 - The Ticketing Co. (Tixco, LLC) reserves the right to use, collect, store and otherwise utilize any and all financial data entered into its software and/or server, whether by ticket sellers, venders, or purchasers, for whatever purposes The Ticketing Co. (Tixco, LLC) shall decide. However, The Ticketing Co. (Tixco, LLC) will never sell or otherwise share this financial date with any unauthorized third party.
- *Third Party Websites and Services:*
 - The Ticketing Co. (Tixco, LLC) employs other companies and individuals to perform tasks and functions on its behalf and we need to share your information with these entities.
 - Some The Ticketing Co. (Tixco, LLC) features include access to and integration with social media platforms, which are controlled by non-affiliated third parties. You use such third parties at your own risk and hold harmless The Ticketing Co. (Tixco, LLC) for any claims against these third parties. Any Third Party service accessed from the The Ticketing Co. (Tixco, LLC) website is independent from The Ticketing Co. (Tixco, LLC) and The Ticketing Co. (Tixco, LLC) has not control over. The Ticketing Co. (Tixco, LLC) may release your information when we believe in good faith that such disclosure is necessary to comply with the law, prevent imminent physical harm or financial loss, or investigate or take action regarding illegal activities, suspected fraud, or violations of the The Ticketing Co. (Tixco, LLC) Producer and/or Buyer Agreements.
 - The Ticketing Co. (Tixco, LLC) may disclose personally identifiable information to parties in compliance with our Copyrights and Intellectual Property Policy. The Ticketing Co. (Tixco, LLC), in its sole discretion, in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity, may disclose the name, address, country, phone numbers, email address and company name.
- *Contact from The Ticketing Co. (Tixco, LLC):*
 - Occasionally, The Ticketing Co. (Tixco, LLC) will send you messages via email.
 - Additionally, The Ticketing Co. (Tixco, LLC) may provide you with newsletters, new features, or other information. You will always have the ability to easily opt out of these newsletters.
- *Your Consent:*
 - By using The Ticketing Co. (Tixco, LLC) system to list an event for ticket sales, or by purchasing tickets or registering for an event, you consent to the terms of this policy. If you do not consent to the collection, use, or disclosure of your personal information as outlined in this policy, please do not provide any personal information to The Ticketing Co. (Tixco, LLC).
- *Security:*
 - No transmission of data over the Internet can be considered 100% secure. However, The Ticketing Co. (Tixco, LLC) takes every reasonable precaution to protect your personal information, privacy and security.
- *Changes to this Privacy Policy:*
 - The Ticketing Co. (Tixco, LLC) may at any time, without notice to you and in its sole discretion, amend this policy from time to time. Please review this policy periodically. Your continued use of the The Ticketing Co. (Tixco, LLC) system and website after any such amendments signifies your acceptance thereof.

- **COPPA NOTICE:** The Ticketing Co. (Tixco, LLC) hereby declares in Good Faith, that, in compliance with The Children’s Online Privacy Protection Act of 1998 (COPPA), 15 U.S.C. §§6501-6506, Tixco LLC will make every reasonable effort to comply with the spirit of COPPA should it be determined that services provided via the website operated by Tixco, LLC fall within the purview of COPPA:
 - The Ticketing Co. (Tixco, LLC), a New York Limited Liability Company, operates this website for the purpose of facilitating ticketing services for entertainment ventures. As described in the Terms and Conditions, agreement to which serves as a mandatory prerequisite of use of the website, The Ticketing Co. (Tixco, LLC) collects personally identifiable information directly from users of the website. The type of personal identifiable information that may be collected at that time includes, but is in no way limited to, names, billing addresses, email addresses, and credit card billing information. A user of this website is to guarantee himself or herself to be of eighteen (18) years of age and, if not, that parental permission for use of this website has been obtained by the user per the following:
 - By agreeing to the terms of service of this website, purchaser hereby agrees that purchaser is eighteen (18) years of age or older. If purchaser is not eighteen (18) years of age, purchaser hereby agrees to provide the following information to The Ticketing Co. (Tixco, LLC) in compliance with 16 C.F.R. § 312.4 as it relates to purchaser’s parent or legal guardian:
 - Parent or Legal Guardian’s Online Contact Information;
 - Parent or Legal Guardian’s Consent for the Collection, Use, or Disclosure of any of purchaser’s information for business or partner/affiliate business purposes;
 - The website uses the personally identifiable information provided by users for internal operating purposes, for record keeping and billing. The website also shares the information with affiliated businesses and corporation for purposes of cross-business advertising, as well as with the producers of the event for which the user’s information is being supplied.
 - To create an account on the website for an individual under the age of eighteen (18) years, a parent or legal guardian completes the registration process for his or her child or ward. To create a membership account for the minor, the parent or guardian must, among other requirements, (i) provide information about the parent/guardian and his/her child/ward as prompted by the registration process; (ii) agree to the Terms and Conditions of use and Privacy Policy; (iii) review and consent to the website’s Terms and Conditions and Privacy Policy in collecting and using personal information from children under 13 years of age as specified in this COPPA NOTICE; and (iv) submit the parent’s credit card information to pay necessary fees for purchase of tickets on the website.
